QUALIFICATIONS:

APPLICATION PROCESS:

1. Complete and submit the NABOR Nadine Yates Memorial Scholarship Application Form. Applications must be completed in their entirety, including the essay questions.
2. A recommendation letter from a member of NABOR must accompany application.
3. Signed and dated Memorandum of Understanding must accompany application.

APPLICATION REVIEW PROCESS:

1. Applications and all supporting documents must be received prior to March 15, 2019 to be considered for a scholarship.
2. The Scholarship Committee will review applications for eligibility and content, then will make a recommendation to the Board of Directors for approval.
3. After the selection process and final approval from the Board of Directors of NABOR, all applicants will receive written notice advising them whether they have been awarded a scholarship. If you receive a scholarship your notification letter will specify the date scholarship money will be distributed.
