

Members of the Northwest Arkansas Board of REALTORS® (NABOR) adhere to a strict code of ethics and abide by the rules of the Arkansas Real Estate Commission. The purpose of our Multiple Listing Service (MLS) is the orderly correlation and dissemination of listing information to participants and their subscribers, so they can better serve the buying and selling public. Through the MLS, your broker can make your home available to every other subscriber in the MLS. This service greatly increases the exposure of your property to potential buyers, thereby insuring the highest and best price and terms for the sale of your property. MLS participants are required to submit all real estate listings for sale or lease within the NABOR MLS service area. Exceptions can be made ONLY upon receipt of written instructions by the property owner(s) to withhold the listing, or when the property is listed as an Office Exclusive.

- 1. Seller's Authorization to Withhold/Office Exclusive means that you are instructing your brokerage to withhold or delay the listing from publication in the MLS from marketing to the public and you wish to exclude any other real estate office from showing or selling your home. For the period of time that you opt to withhold the listing from the MLS, your property will **not** be seen by over 3,000 MLS subscribers, will **not** be included in automated MLS alerts to potential buyers, will **not** be displayed on REALTOR.com, Zillow and other websites, and WILL NOT BE ADVERTISED TO THE PUBLIC OR AGENTS.
- 2. Coming Soon means the property **WILL NOT BE SHOWN** by anyone, including the listing firm.
